II. Object of the contract

V. Liabilities

- c. to fully provide the technical equipment necessary for the good progress of the event stipulated in this contract;
- d. to provide the transport for the band and the equipment from the company premises to the event location and back, all over the country;
- e. to provide accommodation for the band before and after the event, all over the country.

V.2. The Beneficiary undertakes:

- a. to pay a visit to the company's headquarters for the purposes of signing the contract and paying the amount in advance, representing the minimum 35% from the total price of the event;
- b. to provide support and assistance to the Executor for the installation and the uninstallation of the equipment;
- c. to provide, during the event, strict supervising of valuable goods that the Executor has with him. Valuable goods are: vehicle, photo camera, video camera, mobile phone, advertising materials;
- d. to provide a civilized unfolding of the event, the physical safety of the band, as well as the safety of the whole equipment;
- e. not to communicate and spread in public statements regarding the Executor and his activity meant to delude or to bring moral and financial damages, or to create an adverse situation to the advantage of another person or legal entity;
- f. to announce at least 15 working days in advance any change occurred in those established by the parties upon the signing of the contract;
- g. to pay in advance to the Executor the minimum 35% from the total price of the event, at the signing of the contract;
- h. to fully pay his financial obligations towards the Executor the moment the event is over.

VI. Litigations

VI. 1. The parties agreed that all litigations regarding this contract will be solved amicably by their representatives.

VI. 2. If the litigations cannot be solved amicably, the parties will resort to competent legal instances.

VII. Final clauses

VII. 1. This contract represents the will of both parties, and annuls any other verbal agreement between them, prior or subsequent to its signing.

VII. 2. This contract will terminate by:

VII. 2. a. ending of the event stipulated in the contract;

VII. 2. b. if one party renounces. In case of renouncing, any party is obliged to do that with a 30 working days notice. If the Executor renounces, he undertakes to give back to the Beneficiary the amount paid in advance stipulated in the contract. If the beneficiary renounces, he undertakes not to have any claims concerning the amount paid in advance by the beneficiary to the executor, which amount is stipulated in the contract.
